

Santa Cruz Irrigation District No. 15's intention and desire to convert into a water control and improvement district operating under Chapter 51, Texas Water Code, and Article XVI, Section 59, of the Texas Constitution as reflected in the Resolution hereinbelow.

RESOLUTION OF THE  
BOARD OF DIRECTORS OF  
SANTA CRUZ IRRIGATION DISTRICT NO. 15

A RESOLUTION approving and authorizing publication of notice of its intention to convert into a water control and improvement district operating under Chapter 51, Texas Water Code, and under Article XVI, Section 59, of the Texas Constitution

WHEREAS, Santa Cruz Irrigation District No. 15 ("District") is an irrigation district created under Article XVI, Section 59 of the Texas Constitution and operating under Chapter 58 of the Texas Water Code; and

WHEREAS, the Board of Directors of Santa Cruz Irrigation District No. 15 has determined that, in its judgment, conversion into a water control and improvement district operating under Chapter 51, Texas Water Code, and under Article XVI, Section 59 of the Texas Constitution would serve the best interests of the District and would be a benefit to the land and property included in the District; and

WHEREAS, the Board of Directors of Santa Cruz Irrigation District No. 15 has determined that it desires to convert into a water control and improvement district operating under Chapter 51, Texas Water Code, and under Article XVI, Section 59, of the Texas Constitution; and

WHEREAS, prior to such conversion, the District is required to public notice of its desire to convert into a water control and improvement district operating under Chapter 51, Texas Water Code, and under Article XVI, Section 59, of the Texas Constitution and adoption of its Resolution in accordance with the requirements of Chapter 51, Texas Water Code, and Article XVI, Section 59 of the Texas Constitution. Therefore,

BE IT RESOLVED BY SANTA CRUZ IRRIGATION DISTRICT NO. 15:

**SECTION 1:** The President is hereby authorized and directed to cause notice to be published of Santa Cruz Irrigation District No. 15's adoption of a resolution reflecting its intention and desire to convert into a water control and improvement district operating under Chapter 51, Texas Water Code, and Article XVI, Section 59, of the Texas Constitution. The notice hereby approved and authorized to be published shall read substantially in the form and content of Exhibit A attached hereto and incorporated herein by reference as a part of this resolution for all purposes.

**SECTION 2.** The President shall cause the aforesaid notice to be published in a newspaper of general circulation in Hidalgo County, Texas, once a week for two (2) consecutive weeks, with the date of the first publication being not less than fourteen (14) full days before the date and time stated therein for a hearing on the matter to be considered at such meeting, including this Resolution.

**SECTION 3.** The hearing on Santa Cruz Irrigation District No. 15's adoption of a resolution to be converted into a water control and improvement district operating under Chapter 51, Texas Water Code, and Article XVI, Section 59 of the Texas Constitution shall be set for June 12<sup>th</sup>, 2024, at 12:00 o'clock P. M., and the offices of Santa Cruz Irrigation District, 601 FM 2812, Edinburg, Hidalgo County, Texas 78542 at which time and place all interested persons may appear and offer testimony for or against the proposal contained in this Resolution.


